Rule: 5180-37:04 Ratio and Group size: General education or co-taught classroom

Code: This rule requires children 4 years and 5 years not in kindergarten must have a staff/child ratio of 1:14.

Findings: During the inspection, in a general education in the AM session, there were 6 typical students to 7 IEP students. This does not meet the requirements for a general education classroom.

#### Domain: 01 Ratio & Supervision

Rule: 5180-37:04 Preschool special education law requirements

Code: This rule requires a preschool special education program to meet the child/staff ratio requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code.

Findings: During the inspection, the preschool special education program did not meet requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code.

#### Domain: 01 Ratio & Supervision

Rule: 5180-37:04 Ratio and Group size: Integrated classroom

Code: This rule requires the staff ratio of one teacher for every eight children to be maintained at all times with a center-based teacher, and a second adult shall be present when there are nine or more children, including nondisabled children enrolled in a class session.

Findings: During the inspection, rooms 8, 9, and 10 were identified as integrated classrooms. Room 8 AM session had 8 IEP to 2 Typical, PM session had 7 IEP to 4 typical. Room 9 AM session had 8 IEP to 4 typical, PM session had 8 IEP to 2 typical. Room 10 AM session had 8 IEP to 4 typical, PM session had 8 IEP to 2 typical. These numbers do not meet the integrated room requirements.
