Code: This rule requires a preschool special education program to meet the child/staff ratio requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code.

Findings: During the inspection, the preschool special education program did not meet requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code. Classroom A104 was identified as an integrated classroom however; the current enrollment is 8 IEP students and 4 typical peers.

Rule: 5180-37:05 Children supervised during travel times

Code: This rule requires that groups of children are supervised during the use of and traveling to and from the play area

Findings: During the inspection, it was observed that a child was not supervised during traveling from the office to the classroom and out to the playground.
