Domain: 01 Ratio & Supervision

Rule: 3301-37:04 Preschool special education law requirements

Code: This rule requires a preschool special education program to meet the child/staff ratio requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code.

Findings: During the inspection, the preschool special education program did not meet requirements of section 3323.022 of the Revised Code and rule 3301-51-11 of the Administrative Code. PS Room 36 identifies as an Integrated Classroom, however, the AM group has 8 children with disabilities and 10 children without disabilities, and the PM group has 8 children with disabilities and 12 children without disabilities. PS Room 37 identifies as an Integrated Classroom, however, the AM class has 8 children with disabilities and 12 children without disabilities, and the PM group has 8 children with disabilities and 11 children without disabilities. All groups exceed the maximum number of children for Integrated classrooms.

Low Risk Non-Compliances

Domain: 08 Staff Files

Rule: 3301-37:04 Staff with required health and safety trainings

Code: This rule requires the program to ensure at least one preschool staff member who has completed and is current with a child abuse recognition and prevention course based on an approved curriculum. The child abuse recognition and prevention curriculum used in the course may be consistent with requirements as established by section 3319.073 of the Revised Code or appear on the approved curriculum list posted on the departments website. Consistent with requirements as established by section 3319.073 of the Revised Code, such staff shall complete at least four hours of in-service training in child abuse recognition and prevention within two years of employment and every five years thereafter.

Findings: During the inspection and review of staff files, at least one person onsite does not have a current course on the recognition and prevention of child abuse from an approved provider.

Rule: 3301-37:04 Orientation training

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have an orientation training as prescribed by the department completed within thirty days of the individuals start date.



Findings: During the inspection and review of staff files, one individual used in ratio did not have documentation of the required orientation training prescribed by the department completed within thirty days of the start date.
