Findings: During the inspection and review of staff files, individuals used in ratio did not have evidence of criminal background checks to meet the requirements for the Child Care and Development Block Grant (CCDBG) when serving children under publicly funded child care or head start programs.

Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include a medical signed by a licensed physician.

Code: This rule requires all preschool programs are to comply with the Ohio department of health safe sleep procedures.

Findings: During the inspection, it was determined that the written safe sleep policy did not include compliant safe sleep procedures. Additionally, the program was not complying with the Ohio Department of Health safe sleep procedures in that crib mattress sheets were to large and loose and did not fit securely around the mattress.
