Findings: During the inspection and review of staff files, individuals used in ratio did not have evidence of criminal background checks (FBI) that meet the requirements.

Documentation that reports and five-year updates are sent to the district or the department's office of educator licensure as required by section?3319.391?of the Revised Code shall be kept on file.

Findings: During the inspection and review of staff files, background checks to meet the Child Care and Development Block Grant (CCDBG) for programs serving children under publicly funded child care or head start were not updated every five years.
