Rule: 5180-37:07 Written medication policy requirements

Code: This rule requires medication to be administered with policies in place that assure child information is gathered and health professional instructions are followed

Findings: During the inspection, it was determined the following requirement was not met:

- \* Medication not on site and available to be administered as needed.

**Low Risk Non-Compliances**

**Domain: 05 Health & Safety**

Rule: 5180-37:07 Handwashing and disposable towels or air hand dryer available

Code: This rule requires that all preschool staff members wash their hands with soap and running water after each diaper change, or after assisting a child with toileting; after cleaning; after toileting; before preparing or eating food; before feeding any child; and when hands have been in contact with nasal or mucous secretions. Disposable towels or an air hand dryer shall be available at all times.

Findings: During the inspection, it was observed that all preschool staff members did not wash their hands with soap and running water after each diaper change, or after assisting a child with toileting; after cleaning; after toileting; before preparing or eating food; before feeding any child; and when hands have been in contact with nasal or mucous secretions.

**Domain: 07 Diapering & Infant Care**

Rule: 5180-37:12 Diapering requirements

Code: This rule requires if diapers are to be changed in a crib or at a central changing station, there shall be some separation material between the child and the changing surface. The material shall be discarded and replaced after each change. If the crib bedding becomes wet or soiled during the diaper change, it is to be replaced with clean bedding.

Findings: During the inspection, separation material used for diapering was not discarded or replaced between children.

**Domain: 08 Staff Files**

Rule: 5180-37:04 Public preschool general education teacher requirements

Code: This rule requires a public school preschool general education class as defined in rule 3301-51-11 of the Administrative Code shall have a lead teacher that meets one of the following during instructional time: (a) Valid prekindergarten teaching certificate issued under section 3319.22 of the Revised Code; or (b) Valid prekindergarten associate license issued under section 3319.22 of the Revised Code; or (c) Valid kindergarten-primary certificate issued under section 3319.22 of the Revised Code and have completed at least four courses in child development or early childhood education from an accredited college, university, or technical college.

Findings: During the inspection and review of staff files, the public preschool general education teacher did not have a valid prekindergarten teaching certificate, associate license, or early childhood license to meet requirements of the position.

**Domain: 09 Children's Files**

Rule: 5180-37:08 Child medical statement

Code: This rule requires that the parent provide, prior to the date of admission or not later than thirty days after date of admission, and every thirteen months from the date of examination thereafter, a medical statement affirming that the child is in suitable condition for enrollment in the program. "Prior to the date of admission" means: The medical statement shall be provided by a physician, physician's assistant, clinical nurse specialist, or certified nurse.

Findings: During the inspection, and a review of children's files, it was determined that the medical statements were not updated every thirteen months from the date of examination
