Code: This rule requires the management of communicable diseases policy which at a minimum meets the requirements of rule 3301-37-11 of the Administrative Code.

Findings: During the inspection and review of program policies, the communicable disease policy did not meet requirements of rule 3301-37-11.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:07 Written procedures for incident and injury reporting

Code: This rule requires providing written notification to parents when a child is injured or a serious health/safety incident occurs and maintaining a log of all injury/incident reports.

Findings: During the inspection, it was determined that the program does not maintain a log of all injury/incident reports.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Reporting abuse policy

Code: This rule requires the discipline policy to include the following: A staff member who suspects that a child has been abused or neglected is to immediately notify the public children services agency and a serious incident report is to be completed and submitted to the department in accordance with section 2151.421 of the Revised Code.

Findings: During the inspection policy review; reporting abuse procedures were missing.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable disease policy: Training staff

Code: This rule requires each program to have a written policy concerning the management of communicable disease. The policy shall include: the program's means of training all preschool staff in signs and symptoms of illness and in hand-washing and disinfection procedures.

Findings: During the inspection, the program's written communication policy did not include policies for training all preschool staff in signs and symptoms of illness and in handwashing and disinfecting procedures.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Staff responsibility for discipline

Code: This rule requires a preschool staff member in charge of a child or a group of children shall be responsible for their discipline.

Findings: During the inspection policy review, the requirement for a preschool staff member to be responsible for discipline was missing.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Exposure to a communicable disease

Code: This rule requires each program to have a written policy concerning the management of communicable disease. The policy shall include: Procedures for notifying all parents of enrolled children when children are exposed to a diagnosed communicable disease such as pink eye, ringworm, chicken pox, or lice.

Findings: During the inspection review, the procedures for notifying all parents of exposure to a diagnosed communicable disease was not included in the communicable disease policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: During the inspection, it was determined the policy for discipline did not include that the methods of discipline shall apply to all persons on the premises.

Findings: During the inspection and policy review, the behavior management/discipline policy did not include that the center's actual methods of discipline shall apply to all persons on the premises.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: Discipline shall not be imposed on a child for failure to eat, failure to sleep, or for toileting accidents.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: No child shall be placed in a locked room or confined in an enclosed area such as a closet, a box, or a similar cubicle.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: No physical restraints shall be used to confine a child by any means other than holding a child for a short period of time, so the child may regain control.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: Discipline shall not include withholding food, rest, or toilet use, and food shall not be used as a reward for behavior.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following: The center shall not abuse or neglect children and shall protect children from abuse and neglect while in attendance in the preschool program.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: Separation, when used as discipline shall be brief in duration and appropriate to the child's age and developmental ability, and the child shall be within sight and hearing of a preschool staff member in a safe, lighted, and well-ventilated space.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: Techniques of discipline shall not humiliate, shame, or frighten a child.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline restrictions

Code: This rule requires the discipline policy to include the following restriction: No child shall be subjected to profane language, threats, derogatory remarks about himself or his family, or other verbal abuse.

Findings: During the inspection review, discipline restrictions were missing from the policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Readmitting an ill child

Code: This rule requires each program to have a written policy concerning the management of communicable disease. The policy shall include: Procedures for isolating and discharging an ill child and policy for readmitting such child.

Findings: During the inspection review, the policy for readmitting an ill child was missing.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include the following: a child isolated due to suspected communicable disease to be within sight and hearing of an adult at all times. No child shall ever be left alone or unsupervised.

Findings: During the inspection review, the policy for communicable disease was missing the requirement for the isolation space to be within sight and hearing of an adult at all times.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include a child isolated due to suspected communicable disease to be made comfortable and provided with a cot/mat or crib for infants. All linens and blankets used by the ill child shall be laundered before being used by another child. After use, the cots shall be disinfected with an appropriate germicidal agent, or, if soiled with blood, feces, vomit, or other body fluids, the cots shall be cleaned with soap and water and then disinfected with an appropriate germicidal agent.

Findings: During the inspection review, the policy for communicable disease did not include the cot/mat crib requirements when used by an ill child.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include a child isolated due to suspected communicable disease to be discharged to parent, guardian, or person designated by the parent or guardian as soon as practical.

Findings: During the inspection review, the policy for communicable disease did not include the requirement to discharge an ill child to a parent, guardian or other person as soon as possible.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include a child isolated due to suspected communicable disease to be observed carefully for worsening condition.

Findings: During the inspection review, the policy for communicable disease did not include the requirement to observe a child showing symptoms of illness.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Ill child isolation requirements

Code: This rule requires the communicable disease policy to include the following: a child isolated due to suspected communicable disease to be cared for in a room or portion of a room not being used in the preschool program.

Findings: During the inspection review, the policy for communicable disease was missing the requirement for the room or portion of a room used to isolate an ill child

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Parent notification of illness

Code: This rule requires a written communicable disease policy that includes immediately notifying the parent or guardian when their child has been observed with signs or symptoms of illness.

Findings: During the inspection policy review, notification of parents was missing from the precautions taken for an ill child in the communicable disease policy

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline policy ensures well being of individuals

Code: This rule requires the written Behavior management/discipline policies and procedures to ensure the safety, physical, and emotional well-being of all individuals on the premises.

Findings: During the inspection policy review, behavior management/discipline policies and procedures did not include ensuring the safety, physical, and emotional well-being of all individuals on the premises.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Written discipline policy requirements

Code: This rule requires the centers written discipline policy is to comply with 3301-35-15 Administrative Code Standards for the implementation of positive behavior intervention supports and the use of restraint and seclusion.

Findings: During the inspection policy review, it was noted section 3319.46 of the Revised Code and rule 3301-35-15 of the Administrative Code requirements were missing.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Written discipline policy requirements

Code: This rule requires the policy to include constructive, developmentally appropriate child guidance. Management techniques are to be used at all times, and shall include such measures as redirection, separation from problem situations, talking with the child about the situation, and positive reinforcement for appropriate behavior.

Findings: During the inspection, the developmentally appropriate techniques were missing from policy.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Written discipline policy requirements

Code: This rule requires a written discipline policy describing the center's philosophy of discipline and the specific methods of discipline used at the center. This written policy shall be on file at the center for review.

Findings: During the inspection, the written discipline policy describing the center's philosophy of discipline and the specific methods of discipline used at the center was not on available for review.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Staff receive discipline policy

Code: This rule requires all preschool staff members to receive a copy of the center's discipline policy for review upon employment.

Findings: During the inspection, evidence that staff received a copy of the discipline policy was not available.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with difficult or rapid breathing shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: difficult or rapid breathing.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with redness of the eye or eyelid, thick and purulent (pus) eye discharge, matted eyelashes, burning, itching or eye pain shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Redness of the eye or eyelid, thick and purulent (pus) eye discharge, matted eyelashes, burning, itching or eye pain.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with severe coughing, causing the child to become red or blue in the face or to make a whooping sound shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Severe coughing, causing the child to become red or blue in the face or to make a whooping sound.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with a stiff neck with an elevated temperature shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: A stiff neck with an elevated temperature.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with a temperature of one hundred degrees Fahrenheit taken by the auxiliary method when in combination with other signs of illness shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: A child with a temperature of one hundred degrees Fahrenheit taken by the auxiliary method when in combination with other signs of illness shall be immediately isolated and discharged to his parent or guardian.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with untreated infected skin patch(es) shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Untreated infected skin patch(es).

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with evidence of untreated lice, scabies, or other parasitic infestation shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Evidence of untreated lice, scabies, or other parasitic infestation.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with unusually dark urine and/or grey or white stool shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Unusually dark urine and/or grey or white stool.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with vomiting more than one time when accompanied by any other sign or symptom of illness shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Vomiting more than one time when accompanied by any other sign or symptom of illness.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with yellowish skin or eyes shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: yellowish skin or eyes.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with diarrhea (three or more abnormally loose stools within a twenty-four-hour period) shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Diarrhea (three or more abnormally loose stools within a twenty-four-hour period).

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the policy for communicable disease to include isolation and discharge precautions for specific symptoms of children suspected of having a communicable disease.

Findings: During the inspection review it was determined the policy for communicable disease was missing isolation and discharge precautions.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation and discharge

Code: This rule requires the following precaution to be taken for children suspected of having a communicable disease: A child with sore throat or difficulty swallowing shall be immediately isolated and discharged to his parent or guardian.

Findings: During the inspection review, it was determined the policy for communicable disease was missing the requirement to isolate and discharge a child with the following symptom: Sore throat or difficulty swallowing.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:10 Discipline policy/ behavior management communication and written consent to parent

Code: This rule requires the parent of a child enrolled in a center to receive the center's written discipline policy.

Findings: During the inspection review, evidence that parents received a copy of the discipline policy was not available.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Symptoms of illness for isolation

Code: This rule requires a management of communicable disease policy to include the precaution that a child with unusual spots, rashes or an elevated temperature be immediately isolated from other children and watched for symptoms that require discharge. Decisions regarding whether the child should be discharged immediately or at some other time during the day shall be determined by the director and the parent or guardian.

Findings: During the inspection review, the policy for communicable disease was missing the following requirement: A child with unusual spots or rashes; or an elevated temperature shall be immediately isolated from other children.

Domain: 10 Written Policies & Procedures

Rule: 5180-37:11 Communicable Disease Policy: Mildly ill child

Code: This rule requires each program to have a written policy concerning the management of communicable disease. The policy shall include: Procedures regarding the care of a mildly ill child.

Findings: During the inspection review, the procedures regarding caring for a mildly ill child was not included in the communicable disease policy.
