Code: This rule requires the preschool staff member/child ratio to be maintained at all times and no child is ever left alone or unsupervised.

Findings: A group of children were observed left alone or unsupervised.

#### **Moderate Risk Non-Compliances**

##### **Domain: 01 Ratio & Supervision**

Rule: 5180-37:04 Nap/rest time ratio requirements

Code: This rule requires at least one preschool staff member shall be physically present in the room at all times during nap/rest time of children over the age of eighteen months.

Findings: During the inspection, a preschool staff member was not present at all times when children were napping or resting.

#### **Low Risk Non-Compliances**

##### **Domain: 02 Safe & Sanitary Environment**

Rule: 5180-37:05 Electrical outlets

Code: This rule requires that electrical outlets are to be covered when not in use unless documentation is on file that the outlets are tamper resistant.

Findings: During the inspection, it was observed that electrical outlets in the wall and on power strips were not covered when not in use and there was no documentation on file to indicate the outlets are tamper resistant.

##### **Domain: 05 Health & Safety**

Rule: 5180-37:09 Screen time during meal or snack time

Code: This rule requires programs to turn off all screens during meal and snack times.

Findings: During the inspection, screen time during meal or snack time was observed.

##### **Domain: 08 Staff Files**

Rule: 5180-37:04 Non-guilty non-conviction statement

Code: This rule requires any individual who may have an assigned schedule with a preschool child (or group) or may be used to count in ratio is obligated to have a signed non-guilty non-conviction statement on a prescribed form signed annually.
