Findings: During the inspection and review of staff files, individuals used in ratio did not have evidence of criminal background checks that meet the requirements.

Findings: During the inspection, and a review of children(s) files, it was determined that the health record of each child did not include:

- A list of any chronic physical problems and any history of hospitalization
- A list of any diseases the child has had.

Rule: 5180-37:07 Health and safety procedures

Code: This rule requires that policies shall address health and safety procedures.

Findings: During the inspection, it was determined that program policies did not address the following. Please update the program policies and procedures to address the following:

- Reporting abuse procedures were missing.
