Findings: During the inspection, and a review of children's files, it was determined that the health record of each child did not include immunization records.

The health record of each child shall include but not be limited to a statement signed by a licensed physician as required by paragraph (A) of this rule.

Findings: During the inspection, and a review of children's files, it was determined that the health record of each child did not include a medical signed by a licensed physician.
