Cleaning and sanitizing is not to take place while rooms are occupied by children, except for general cleanup activities such as sweeping, vacuuming, mopping and wiping off tables which are part of the daily routine.

Findings: During the inspection, it was observed that the center stored a plunger within the reach of the children in the restroom. Submit the program's corrective action plan to verify compliance with the rule requirement.
