Allegation: The complainant alleges that some ceiling tiles are stained and insulation is falling out.

Determination: Substantiated

Findings: Children in care shall be protected from any items and conditions which threaten their health, safety, and well-being. During the inspection, it was determined that children were not protected from the following item(s) or condition(s) which may threaten their health, safety, or well-being as noted in number 12 below:

1. Open pull cords that are not closed loop.
2. Telephone cords.
3. Electrical/extension cords attached to an object that would not likely result in a severe injury if pulled.
4. Stacked chairs.
5. Employee(s) purse(s).
6. Diaper bags.
7. Television not securely anchored.
8. Small or lightweight pieces of shelving units are not securely anchored to the wall.
9. Smoke detector needing batteries replaced.
10. Staff member stepped over a barrier/gate while holding a child.
11. Emergency exits were blocked by the following classroom furniture: [ ].
12. Other- In the back room that leads to outside- multiple ceiling tiles are out and/or in the process of falling out. Multiple areas of insulation exposed, falling out of ceiling.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the hazards were fixed, to the Department to verify compliance with the requirements of this rule.
