Serious Risk Non-Compliances

A serious risk non-compliance is a licensing rule violation that has the potential to lead to a great risk of harm to a child and is observable and/or based on facts.

Domain: 02 Safe & Sanitary Environment

Rule: 5180:2-12-12 Safe Environment

Requirement: The program is required to prohibit weapons, firearms, and ammunition from the premises. Individuals who are permitted to carry a weapon in a child care center include law enforcement officials, active duty members of the U. S. armed forces and individuals with a valid concealed handgun license.

Finding: During the inspection, it was determined there were [weapons/firearms/ammunition] on the premises of the program as noted in number(s) [] below:

1. Weapons, firearms, and/or ammunition were accessible to children on the premises.
2. The individual with documentation of a valid exemption did not carry the weapon(s) in a secure manner.

The individual owning or carrying the weapons, firearms and/or ammunition did not have a valid concealed handgun license, was not a law enforcement official with documentation that his or her jurisdiction requires ready and immediate access to the weapon, and/or was not an active duty member of the U.S. armed forces and carrying valid military identification and documentation of successful completion of firearms training that meets the requirements listed in rule.

These items must be removed from the program or proper documentation obtained.

Rule 5180:2-12-03 requires the program to notify parents when a serious risk non-compliance is cited. The notification must inform parents of the serious risk non-compliance and include the Department of Children and Youth website and location of further information regarding the determination. Submit the program's corrective action plan, which includes a statement that the [weapons/firearms/ammunition] have been removed or proper documentation obtained, and a copy of the written parent notification, to the Department to verify compliance with the requirements of this rule.

Rule: 5180:2-12-12 Safe Environment

Requirement: The program is required to store chemicals and machinery in a place that is inaccessible to children. The program is required to provide an outdoor play area away from machinery in operation.

Finding: During the inspection, a potentially hazardous item or toxic substance was used or stored in [] where children had access to it, as noted in number(s) [] below.

Rule: 5180:2-12-11 Separation of Children Under 2 1/2 Years

Requirement: The program is required to separate children younger and older than 2 1/2 years of age.
