Code: The program staff are not permitted to leave children unattended.

<u>Finding</u>: The program submitted a self-report regarding supervision, a school age child left the center building. A call was made to the center. It was stated that a school age child arrived to the center earlier than scheduled. The child was observed, by a child care staff member, outside of the building and the child was brought into the center. The child was left with another child care staff member who was unaware that the child arrived earlier then scheduled and was with the group. This child then left the building without the staff member's knowledge. Children must be supervised and within sight and hearing of a child care staff member at all times. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
