1. The plan was not posted on each level of the home used for child care.
2. The name, address and telephone number of the program were not complete.
3. The location of the first aid kit, fire extinguisher and fire alarm system, fire alarm pull stations and electrical circuit box were not complete.
4. The telephone number for emergency squad, fire department hospital, poison control program, public children services agency, local health department, local emergency management agency and police department were not complete.
5. Location of children's records was not complete.
6. Emergency information including any medications or supplies needed in the event of an evacuation was not complete.
7. The current version of the prescribed form was not used.
8. The plan was not implemented when necessary in that [].

Rule: 5101:2-13-16 Medical, Dental, and General Emergency Plan

Findings: During the inspection, it was determined the current version of the prescribed JFS 01201 "Dental First Aid" was not posted. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Rule: 5101:2-13-16 Disaster Plan

Code: The program is required to train child care staff members and employees on the written disaster plan annually and keep written documentation of the training on-site.

Findings: During the inspection, it was determined the program's written disaster plan did not meet the requirement for training child care staff members and employees on the plan annually as noted in number(s) 2 below:

1. Child care staff members and employees were not trained annually.
2. Written documentation of the training was not kept on file.

Domain: 07 Diapering & Infant Care

Rule: 5101:2-13-20 Crib and Playpen Requirements

Code: The program staff is required to place infants in a crib or playpen on their back to sleep unless documentation is on file.

Findings: During the inspection, it was determined that infants possibly were placed in a position other than on their backs to sleep or were able to roll over due to initially placed in a position other than on their back to sleep. It was determined that the current version of the prescribed JFS 01235 "Sleep Position Waiver for Child Care" form was not on file, as required by this rule. Submit the program's corrective action plan, which includes a copy of the prescribed form signed by both the child's physician and the parent to verify compliance with the requirements of this rule.
