Findings: During the inspection, it was determined that the provider had an area rug that did not have a nonskid backing or a floor surface that was unsafe in that the outdoor rug posed tripping hazard as it was bunched up in the play area. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule within 30 days.

Code: The provider and program staff are required to make pools on the premises inaccessible to children.

Findings: During the inspection, it was determined a pool was located on the premises and was accessible to children in care as there was no fence or physical barrier as outlined in rule in that a locked door can not function as that physical barrier. An additional barrier must be in place to limit accessibility from the house to the pool area. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule within 30 days.

Findings: In review of records, it was determined the CCSM or Substitute CCSM was left alone with children and did not have current valid documentation for trainings listed in numbers 7 and 14 below:
