Complaint Allegations

Code: The program is required to refrain from using and storing potentially hazardous items, toxic substances, and outdoor machinery around children.

Allegation: MRNC-Downy fabric softer located on the floor between washer and dryer accessible to children (child crawler). Additional chemicals (Lysol spray, Neutrogena sunscreen, Wet one wipes & Tide Antibacterial Spray) located on shelf above couch, children were observed sitting/squatting/standing on couches in reach of items. Another child was also observed jumping off of couch. All items were placed out of reach at the time of inspection.

The county agency has been informed of this non-compliance.

Determination: Substantiated

Findings: During the inspection, a potentially hazardous item or toxic substance was used or stored where children present had access to it as noted in numbers 2, 9, & 14 below. The potentially hazardous substance or item that posed a risk to children was determined to be accessible to children in fabric softener accessible to crawlers as it was on floor and other cleaning chemicals (including aerosols) were present on a shelf accessible from the couch used by children in care.

1. Bleach.
2. Cleaning agent.
3. Fish tank chemicals.
4. Gasoline.
5. Pesticide.
6. Poison, including insect/rodent poison.
7. Flammable substance.
8. Windshield washer fluid.
9. Aerosol cans.
10. A lawn mower.
11. A weed trimmer.
12. Hedge trimmers.
13. A snow blower.
14. Other potentially hazardous substance, equipment or machinery: fabric softener.

Provide staff training. Submit the program's corrective action plan, which includes a statement that the potentially hazardous substance or item is no longer accessible to children and/or children will not be outside when machinery is in use and a statement that training was provided, to the Department to verify compliance with the requirements of this rule. Please provide Corrective Action Plan detailing both short-term and long-term actions to correct within 30 days.
