Findings: During the inspection, it was determined that the permission form, used by the program, for school age children to leave the provider for specific activities did not contain the information noted in item numbers 2,4,& 5 below:

- 1. The child's name;
- 2. The location of the activity;
- 3. Arrangements for going to and from the activity;
- 4. Start and end time of the activity;
- 5. Time period for when permission is given;
- 6. Parent/guardian's signature and date.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
