Rule: 5101:2-13-12 Safe Environment

Code: The program is required to refrain from using and storing potentially hazardous items, toxic substances, and outdoor machinery around children.

Findings: During the inspection, a potentially hazardous item was stored where children present had access to it as noted in number 10 and 14 below. The potentially hazardous substance or item that posed a risk to children was determined to be accessible to children in the backyard.

1. Bleach.
2. Cleaning agent.
3. Fish tank chemicals.
4. Gasoline.
5. Pesticide.
6. Poison, including insect/rodent poison.
7. Flammable substance.
8. Windshield washer fluid.
9. Aerosol cans.
10. A lawn mower.
11. A weed trimmer.
12. Hedge trimmers.
13. A snow blower.
14. Other potentially hazardous substance, equipment or machinery: Grill.



Provide staff training. Rule: 5101:2-13-12 Safe Equipment

Code: The program is required to provide a safe environment that may include items such as fans, pipes, space heaters, and air conditioning units.

Findings: During the inspection, it was determined that the program's equipment was unsafe as noted in the following numbers 6 below:

1. A fan was unstable and could easily tip over;
2. A fan had openings a finger could enter;
3. Pipes from the heat pump felt hot to the touch;
4. The space heater felt hot to the touch;
5. The position of the space heater was a tripping hazard;
6. The air-conditioning unit was not enclosed and was accessible to children on the playground;
