Findings: During the inspection, it was determined the program's written disaster plan did not meet the requirement or was missing the information in numbers 3, 4, 8, 9, 10, 11, 13, 16, 17, 18, and 19 below: Procedures:

- 2. The plan was not provided to all child care staff and employees

- 9. Medical(s) were missing a statement from the physician, PA, APN, or CNP that the child has been immunized or is in the process of being immunized against the diseases

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of
