2. The method did not include each child's name;
3. The method did not include each child's date of birth;
4. The tracking method did not remain with the group at all times;
5. The tracking method was not updated throughout the day as children entered or left the group, in that there were four children in the infant group & only two were marked in and there were eight children marked in on the toddler attendance sheet and six children present..
