Complaint Allegations

Code: The program is required to supervise children.

Allegation: Upon arrival at opening time of 6:00 am Provider is asleep with the door closed and the children are in the childcare area asleep. Children are not within appropriate sight or hearing to provide adequate supervision to get to them quickly if needed.

Determination: Substantiated

Findings: During the inspection, it was determined that children were left unattended and not within sight or hearing when the provider is in her room with the door shut or the door is shut where the children are sleeping. The door must remain open and provider needs to be awake and prepared to greet the families upon the opening of the program. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

Rule: 5101:2-13-08 Employee Requirements

Code: The program staff is required to obtain additional reports or examinations by a licensed physician as noted on the medical statement.

Allegation: The county is requesting a additional report or examination by a health professional due to the concerns of the provider being able to perform duties due to recent illnesses and medications. Provider oversleeps and appears groggy and sleepy when communicating with parents.

Determination: Substantiated

Findings: During the inspection, it was determined that an additional report or examination by a licensed physician or a mental health professional was required as there was a concern about an employee's ability to perform required duties due to recent health issues and medications.. Submit the program's corrective action plan, which includes a copy of the completed medical documentation, to verify compliance with the requirements of this rule.
