2. Stacked chairs;
3. Employee(s) purse(s);
4. Diaper bags;
5. Television not securely anchored;
6. Small or lightweight pieces of shelving units are not securely anchored to the wall;
7. Staff member stepped over a barrier/gate while holding a child;
8. Chipping or peeling paint;
9. iPad cords on the storage shelf in the playroom within children's reach;
10. Playroom floor covered with toys;
11. Office where children walk through to get to the playroom has accumulated items not safe for children

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
