4. Children were exposed to inappropriate [language; conversation; behavior; video; music; DVD] by a [staff member/child/parent].
5. Other: Staff attempted but were unable to reach the child in time to prevent a dog from biting him.

All program employees must take actions to protect children in care. Provide staff training.
