6. There were bushes with red berries within the children's reach.
7. There were bird droppings.
8. There were bolts with more than two threads exposed along a fence line or gate on a playground.
9. The sandbox was contaminated.
10. Other: The paint on the fence was peeling.

6. The date on which the permission was signed.
7. A statement notifying parents how their child will be transported.
8. Other: A statement notifying parents if their children would be near water.
