<u>Code</u>: The program is required to follow the cleaning schedule for equipment.

<u>Finding</u>: During the inspection, it was determined that the items noted in number(s) 1,2 below were not cleaned weekly, or when soiled, as required:

1. Carpets.

2. Floors.

3. Washable furniture.

<u>Finding</u>: Children in care shall be protected from any items and conditions which threaten their health, safety, and well-being. - 7. Television not securely anchored.
- 8. Small or lightweight pieces of shelving units are not securely anchored to the wall.
- 9. Smoke detector needing batteries replaced.
- 10. Staff member stepped over a barrier/gate while holding a child.
- 11. Emergency exits were blocked by the following classroom furniture: [].
