**Rule:** 5101:2-12-20 Cots and Napping

**Code:** The program is required to provide cots/mats that are the appropriate dimensions for children in care.

**Finding:** During the inspection, it was determined that all cots and/or mats did not meet the dimensions as noted in number 3 below:

1. The cot must stand at least 3" but no more than 18" off the floor;
2. The cot must be at least 36" in length and as long as the child is tall;
3. The mat must be at least 1" thick and as wide and long as the child assigned.

Technical assistance was provided at the time of the inspection, and as discussed, please correct this rule noncompliance. A written response for this rule noncompliance is not required at this time.

#### Domain: 05 Health & Safety

**Rule:** 5101:2-12-16 Incident/Injury Reporting

**Code:** The program is required to notify the Department of a serious incident by submitting a JFS 01156 "Serious Incident Reporting for Child Care".

**Finding:** During the inspection, it was determined that a Serious Incident was not reported in the Ohio Child Licensing and Quality System (OCLQS), as required, by the program administrator or designee for an incident as listed in number 1 below:

1. A child received a bump or blow to the head that required first aid or medical attention.
2. An incident, injury or illness that required a child to be removed by the parent or emergency services from the program for medical treatment.
3. A usual or unexpected incident which jeopardizes the safety of a child or employee of the program.
4. An incident defined as a serious risk noncompliance in appendix A to rule 5101:2-12-03 of the Administrative Code.
5. The program did not submit the report in the OCLQS by the next business day as required by rule.
