Findings: During the inspection, it was determined 7 children with 2 under two years of age were in the care of one child care staff member which resulted in more than six children. Submit the program's corrective action plan to verify compliance with the requirements of this rule.

- 16. Dated signature of parent giving permission to perform the procedure was missing.
- 17. Dated signature of program administrator was missing.
- 18. The plan was not implemented.
- 19. The plan was not followed.
