Any equipment designed for climbing, swinging, bouncing, or sliding needs a fall zone of protective material resilient under and around the equipment in order to protect children in the event of a fall. Findings: During the inspection, it was determined the fall zone under and around equipment designated for climbing, swinging, balancing and sliding did not meet the requirements as noted in number(s) 3 below:

1. The fall surface material had not been properly distributed, turned over or raked as needed.

The fall surface material was not being used according to manufacturer's guidelines for its use as a fall surface.
Other No fall surface under inside sliding board. Adequate fall surface must be place under inside sliding board.

The program is required to provide adequate fall zones under and around outdoor play equipment at all times. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
