Findings: During the inspection, it was determined that the provider had not updated the programs hours of operation. Provider also working another job during operating hours of daycare.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to meet the health training requirements.

Findings: In review of records, it was determined the provider did not have current valid documentation for CPR/First aid training.

Correct the violation and submit the documentation of current certification with the program's corrective action plan to verify compliance with the requirement of the rule.
