Allegation: The complainant alleged that a staff member used inappropriate guidance and management techniques while caring for a child at the program.

Determination: Substantiated

Findings: During the inspection, it was determined that a child care staff member used a discipline technique to guide or discipline child(ren) that was not developmentally appropriate, consistent, or occurred at the time of the incident. (A staff member picked up a toddler by the coat collar and forced a child to eat spoonful's of food when he or she did not want to eat anymore. The staff member is no longer employed at the program.) Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
