1. Aggressive argument involving adults;
2. Staff member(s) did not follow emergency exiting procedures;
3. Staff member(s) allowed child(ren) to do something unsafe;
4. Staff member(s) did something unsafe; A staff member did not fasten an infant on a changing table, the staff member removed her hands from the infant resulting in the infant falling off of the changing table.
