Code: The program is required to provide equipment that has openings less than 3 1/2 inches and no more than 9 inches to avoid the risk of entrapment.

Findings: During the inspection, it was determined the "S" hooks on the swing(s) were not closed in order to prevent the chain from slipping off the hook and prevent strangulation. Please purchase a closed swing hook and submit proof of this.

Discontinue the use of this equipment until it has been removed, repaired or replaced. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.
