- 1. The straps were missing on the [].
- 2. The straps were attached, but were not used on the [].
- 3. The straps were attached and were used, but were not used in a safe manner.
- 4. Manufacturer's guidelines for the stuffed animals and puppets were not followed in that the recommended ages on the products were 2 years and up or three years and up, but the group included infants.
