Findings: During the inspection, it was determined the following requirements regarding emergency exits and operational conditions were not met by the program in that the second floor secondary escape window did not have ladder. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to have all outlets and surge protectors covered.

Findings: During the inspection, it was determined that outlets in the play area, dining area and nap area did not have childproof receptacle covers. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
