Code: The program is required to store alcohol in a space not used by children.

Findings: During the inspection, alcohol was determined to be in the refrigerator door on the bottom shelf which was accessible to children. These items must be removed or stored in space not approved or used for children as required. Submit the program's corrective action plan to verify compliance with this rule.

Code: The program is required to have running water below the temperature of 120 degrees Fahrenheit.



Findings: During the inspection, it was determined the water temperature was 125 in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to refrain from using television, computers, or other devices during meals and snacks.

Findings: During this inspection it was determined that the television was on during snack. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.
