Rule: 5101:2-13-12 Carbon Monoxide Detectors - Type B Only

A working carbon monoxide detector must be placed, installed, tested, and maintained in accordance with manufacturer's recommendations. 3. The assigned group for the child;
4. The child's weekly schedule;
5. The time (hours and minutes) of each child's arrival and departure to the program, including transportation by the program.

3. An inspection for properly functioning child and driver restraints;
4. An inspection for properly functioning doors and windows;
5. An inspection for, and cleaning of, debris from the inside of the vehicle;
