Rule: 5101:2-12-20 Cribs
Code: The program staff is required to remove any items listed in rule that are a potential suffocation risk from cribs.

Finding: During the inspection, it was determined that a child had been placed in a crib with an object that created a potential strangulation or suffocation risk, as indicated in number 2 below:

1. Item tied around neck (including bib or pacifier on ribbon or string around child's neck)
2. Blankets for infant under twelve months old
3. Pillow



- 4. Boppy
- 5. Bumper pad
- 6. Clothing stored in the crib
- 7. Diaper bag
- 8. Object or toy strung over the crib in which a child can pull himself up
- 9. Stuffed animal that is large/soft enough to conform to the shape of the child's face
- 10. Other []

The rule prohibits any item which obstructs child-care staff's visibility or poses a risk of strangulation or suffocation from being placed on or in a crib. Remove the items immediately. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
