Rule: 5101:2-13-12 Safe Environment

Code: The program is required to store alcohol in a space not used by children.

Findings: During the inspection, an open container of alcohol was determined to be in spaces approved or used for child care and/or accessible to children present at the program. These items must be removed or stored in a space not approved or used for children as required. Submit the program's corrective action plan to verify compliance with this rule.

Code: The program is required to have background checks for all staff and residents over 18 years of age.

1. Submitting the request for a background check for child care in the OPR;
2. Submitting fingerprints electronically according to the process established by the BCI.

Code: The program is required to refrain from using and storing outdoor machinery around children.

Findings: During the inspections, disinfectant spray, and a spray aerosol was determined to be in reach of children.

Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.
