Code: The program is required to complete a JFS 01299 "Incident/Injury Report" for children who were involved in an incident.

Findings: During the inspection, it was determined that a JFS 01299 "Incident/Injury Report" was not completed by the child care provider for a child that became ill or received an injury which required first aid treatment as required by the rule 5101:2-13-16.

Code: The program staff is required to obtain signed written permission for administering topical products and lotions other than lip balm and hand sanitizer, when using hand sanitizer with children older than 24 months.

Findings: During the inspection, it was determined that the program staff did not obtain signed written permission from the parent prior to administering topical products and lotions, other than hand sanitizer to be used by children older than twenty-four months and lip balm. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule 5101:2-13-25
