Finding: In review of the staff records, it was determined the program did not have at least one child care staff member present/scheduled to be present during all hours of operation with currently valid documentation for the trainings listed in number 1, 4 below:

1. First Aid – child care staff members scheduled during the hours of 6:00 am and 6:00 pm had expired training
2. First Aid – child care staff members scheduled during the hours of [] and [] did not have verification of completion of First Aid

5. The first aid training was expired.
6. The CPR training was expired.

10. Medical(s) were missing a statement from the child's parent or guardian that he or she has declined to have the child immunized against the disease for reasons of conscience, including religious convictions
