<u>Finding</u>: During the inspection, it was determined that there were no landing mats under and/or around the following required indoor climbing equipment: slides in the large muscle room. Provide landing mats at least one and one-half inches thick to be used as a protective surface for the climbing apparatus discussed. Submit the program's corrective action plan, which includes specific information regarding the placement of the landing mats, to the Department to verify compliance with the requirements of this rule.
