Code: The program is required to refrain from using and storing potentially hazardous items, toxic substances, and outdoor machinery around children.

Findings: During the inspection, a potentially hazardous item or toxic substance was used or stored where children present had access to it. In the upstairs bathroom the shower cleaner was accessible and there was toothpaste accessible in the medicine cabinet was well. In the kitchen, drills were considered accessible in a kitchen cabinet. Please also move the accessible home plug in scents that were in the walls to a spot not in reach to children.

In review of the children's records, it was determined that the required written information was either not on file, implemented or followed, for Skylar. If this child no longer needs medication, have the parent fill out a new enrollment form indicating this is not needed.

Findings: During the inspection, it was determined the water temperature was 138 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

- 4. The toilet cleaning brush was accessible to the children.
- 5. The plunger was accessible to the children.
- 6. The toilet was not flushed.
