Rule: 5180:2-12-13 Handwashing Requirements

4. At least one staff/child did not wash their hands after toileting or assisting a child with toileting.
5. At least one staff/child did not wash their hands after each diaper change or pull-up change.
6. At least one staff did not wash their hands after contact with bodily fluids or cleaning up spills or objects contaminated with bodily fluids.

Rule: 5180:2-12-16 Medical, Dental, and General Emergency Plan

1. The plan was not posted in each classroom.
2. The plan was not posted in other spaces used by children. (Lunch Bunch)
3. The name, address and telephone number of the program were not complete.
4. The location of first aid kit, fire extinguishers and fire alarm system, fire alarm pull stations and electrical circuit box were not complete.
5. The telephone number for emergency squad, fire department, hospital, poison control program, public children services agency, local health department, local emergency management agency, and police department were not complete.
6. Location of children's records was not complete.
7. Emergency information including any medications or supplies needed in the event of an evacuation was not complete.
8. The current version of the prescribed form was not used.
9. The plan was not implemented when necessary in that [].

Rule: 5180:2-12-17 Materials and Equipment

Finding: During the inspection, it was determined that the program did not have designated storage areas for children's personal belongings (Lunch Bunch). The rule requires that an area be designated where children can individually store their personal belongings. This area shall not block walkways or evacuation routes.
