Findings: During the inspection, it was determined the water temperature was 130 degrees in the bathroom. This temperature exceeds the requirement of remaining below 120 degrees Fahrenheit. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The provider is required to maintain the required liability insurance or have a completed JFS 01933 "Liability Insurance Statement for Family Child Care Providers" on file for each child in care.

Findings: During the inspection, it was determined the provider did not have a completed JFS 01933 "Liability Insurance Statement for Family Child Care Providers" completed for each child in care. Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.

Code: The program is required to have a completed medical on file for each child.

Findings: In review of of the children's records, it was determined that the JFS 1305 "Child medical statement for childcare", was expired or missing. Medical statements are good for 13 months from the date of examination. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

Code: The program is required to have a completed JFS 01234 "Child Enrollment and Health Information for Child Care" on file on the premises for each child.

Findings: In review of the children's records, it was determined that the JFS 01234 "Child Enrollment and Health Information For Child Care", was either not updated by both parent and administrator or was missing.
