Findings: During the inspection, it was determined that surge outlets did not have childproof receptacle covers in kitchen and program space. Correct the violation and submit the program's corrective action plan to verify compliance with the requirement of the rule.

Correct the violation and submit proof of insurance with the program's corrective action plan to verify compliance with the requirement of the rule.
