Rule: 5101:2-12-19 Supervision

Finding: During the inspection, it was determined that children were not being properly supervised as noted in number(s) 3 below:

2. Child(ren) were not within both sight and hearing of a child care staff member during outdoor play.
3. Child(ren) were not within both sight and hearing of a child care staff member more than once.
4. Staff were not physically present in the space and near enough to respond and reach the child(ren) immediately.
