Finding: During the inspection, required staff/child ratios were not maintained for the same group on multiple occasions, as noted below:



The ratio determined for the combine PS - SA group was 1 Child Care Staff Member(s) for 18 children. Additionally, a ratio of 1 Child Care Staff Member(s) for 14 children was determined for same group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.
