3. Child(ren) left the group and were unattended. In the Buckeye Room, a child went across the hall to the bathroom without teachers noticing.
4. Child care staff were using a baby monitor to supervise children.
5. Child care staff were using a walkie talkie to supervise children.
6. Child care staff were using mirrors to view children in another room.
7. Child care staff were using a video camera instead of physically being present in the room.
