**Finding:** During the inspection, required staff/child ratios were not maintained for a different groups on multiple occasions, as noted below:

The ratio determined for the Get Set group was 2 Child Care Staff Members for 15 children. The youngest child in the group was 2.1 yrs of age.

Additionally, a ratio of 2 Child Care Staff Member for 26 children was determined for the Preschool group.

Additional staff members must be hired or current Child Care Staff Members must be rescheduled to maintain compliance. Provide staff training. Submit the program's corrective action plan, which includes a statement that training was provided, to the Department to verify compliance with the requirements of this rule.

**Low Risk Non-Compliances****Domain: 01 Ratio & Supervision****Rule:** 5180:2-12-18 Group Size**Code:** The program is required to maintain the appropriate group size for each group of children served.

**Finding:** During the inspection, group size limitations were not maintained for the group of Get Set (15) classroom has children under 2 1/2 and Preschool (26) children as it was determined there were 15 toddlers and 26 preschool children grouped together. The group size shall not exceed twice the maximum number of children allowed per Child Care Staff Member. Submit the program's corrective action plan to the Department to verify compliance with the requirements of this rule.

**Domain: 05 Health & Safety****Rule:** 5180:2-12-16 Emergency Drills

Code: The program is required to complete fire drills, weather drills, and emergency/lockdown drills appropriately.

2. Monthly weather emergency drills (March through September): Missed (June, July, and September).
